2. Bidding and award of contract shall be made on a **per lot basis**. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
3. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount state in **ITB** Clause 16. Late bids shall not be accepted.
8. The Pre-Bid Conference shall be open to all prospective bidders.
9. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. The **MUNICIPALITY OF STA. ELENA, CAMARINES NORTE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
